Associated with creation in Islamic thought, ethics is an essential phenomenon for societies formed by individuals to be in peace and order.

Taking action and carrying out these actions according to certain rules of conduct is the most important characteristic that distinguishes humans from other beings. Humans also possess moral actions, characterized as good and bad, right and wrong, that arise while organizing their lives by making voluntary choices among different actions in their relationships with other beings. As a result of this relationship, various duties and responsibilities arise for humans, towards Allah, themselves, other humans, and other beings.

REQUIREMENTS FOR PARTICIPATION

The symposium is open to the participation of academicians, researchers and interested parties. All participants are required to abide by the periods determined in the symposium calendar. The abstract, which includes the purpose, method, source and possible results of the paper, should be expressed in the range of 250-350 words and should be sent to islamvemedenyet@firat.edu.tr until April 30, 2024. Full-text papers should be prepared in the range of 4000 to 9000 words and should not have been presented in writing or orally elsewhere before. Papers must be original and the product of research, not cited from other works, not published anywhere, and sent in a format suitable for publication. Papers can be submitted in Turkish, Arabic or English. Accommodation expenses will be covered by the symposium organization. Transportation expenses belong to the participant. In the event that more than one author prepares the same paper, only one person's accommodation expenses will be covered. For the final participation in the symposium, the full text of the paper must be sent until August 1, 2024 and accepted by the scientific committee. Papers should be prepared in accordance with the full-text writing rules on the symposium website.
